Live It! Grant funds will be awarded to organizations that focus on conservation and promote hunting and fishing. All events must be National Hunting and Fishing Day related and should be held on or around National Hunting and Fishing Day, which is held on the fourth Saturday in September each year. Events may be held as early as August 1st, 2019 through October 31st, 2019. The NHF Day Live It! Grant is designed to support projects that directly and positively impact the mission of getting more families and children outdoors. Events that qualify for funding include but are not limited to: fishing derby's, hunting expos, outdoor expos, and hunting workshops for kids.

Applications will be accepted beginning June 1st, 2019 through July 1st, 2019. All materials must be postmarked by July 1st, 2019 to be considered for funding in 2019. Applications will be reviewed by the committee, and the grant winners will be notified by July 19th, 2019.

Upon notification, grant winners must submit their organizations W-9. Grant funds will be distributed the first week of July, only if the organizations W-9 has been received. Failure to provide the W-9 in a timely manner may result in the loss of funding, at which time the Live It! Grant committee may choose to award the funds to another organization.

A follow up report is required for all grant recipients. The follow up report should include: receipts totaling the grant amount, a 1-page report detailing event attendance, partners, sponsors, give-aways/raffles, and event highlights, as well as photos of the event. Failure to provide this report will result in disqualification from future funding.
