TERMS AND CONDITIONS OF CREDIT

The undersigned (the Applicant) hereby applies for credit with Outdoor World Incentives (a division of Sportsman's Specialty Group, Inc). (The Company).

The applicant hereby agrees and acknowledges that upon acceptance by Company of this Credit Application, the following TERMS and CONDITIONS shall apply:

- ◇ The amount of credit extended is at the sole discretion of the Company.
- ◇ The credit extended by the Company may be modified, withdrawn or amended by the Company at any time without notice.
- ◇ The Company accepts C.O.D. pre-payment, Mastercard, Visa, Discover, and American Express credit cards and the Applicant's business checks with prior written approval of the Company.
- ◇ Payment of invoiced amounts shall be made in full within 30 days of invoice. Any partial payments will be first credited against the oldest invoice.
- ◇ The risk of loss to the accounts shall pass to Applicant when properly addressed and delivered for transfer to Applicant.
- ◇ No accounts will be delivered if payments are not fully current.
- ◇ If checks have been approved in writing, in advance, there will be a \$20.00 service charge for each dishonored check.
- ◇ If collection efforts are necessary, the Applicant agrees to pay all costs of collection fees, including a reasonable attorney's fee and court cost.
- ◇ If an invoice is disputed, the invoice must nevertheless be paid as billed, accompanied by a letter concerning the dispute. Good faith efforts will be extended to reconcile the dispute be for the next billing date.
